Terms and Conditions

Part I: SWIMMING

Swimming is one of the optional daily activities available to children 4+ enrolled in Club Fit Summer Day Camp. Swimming will take place at the Club Fit Briarcliff facility during designated group swim times. Campers are supervised by lifeguard staff on site, a designated camp lifeguard, and the Club Fit Summer Camp Staff. Group ratios, supervision, and buddy checks are conducted in accordance with Westchester County Board of Health camp safety requirements. Each participant can be swim tested by a Certified American Red Cross Water Safety Instructor if requested and depending upon the results categorized as a swimmer or non-swimmer. If no test is given the camper is considered a non-swimmer. To be qualified as a swimmer the participant must complete the following:

Component one* (administered in water less than chest deep of the camper)

* Testing to be administered in Program Pool

- Feet first entry into chest deep water
- Swim front crawl for 25 yards
- Shows the ability to follow the instructions

Component two* (administered in water greater than chest deep only after component one is successfully completed)

* Testing to be administered in Lap Pool

- Maintain position on back 1 minute
- Tread water for 1 minute
- Swim back crawl for 25 yards

We take safety seriously. Students will be expected to follow the pool rules and Club Fit Camp safety rules at all times. These rules will be presented at the start of each swim period daily.

Part II: SUNBLOCK & INSECT REPELLENT

Summer day camp shall allow children attending to carry and use insect repellent and sunscreen with the written permission of a parent or guardian. A child who is unable to physically apply insect repellent or sunscreen may be assisted by unlicensed personnel when directed to do so by the child with written permission by parent or guardian. I give Club Fit camp personnel permission to apply insect repellent and/or sunscreen on my child.
